## Electric heating systems

### Ductless heat pump

- **\$800 rebate**
- Equipment must be certified by the Air-Conditioning, Heating and Refrigeration Institute (AHRI), use inverter technology and be a minimum of 1.0 ton
- Must use electric resistance heat as primary heating source which includes electric zonal (baseboard, cable, wall heater), electric hydronic or electric forced-air furnace
- Must install at least one unit in the main living area of the home. Equipment only installed in a bedroom is not eligible
- Cannot have an existing heat pump or natural gas service, even if only used for cooking

### Geothermal heat pump

- **\$1,500 rebate**
- Must install ENERGY STAR® qualified equipment
- Cannot have an existing geothermal heat pump installed
- Auxiliary heating sources do not qualify for additional rebates

### Electric forced-air furnace (FAF) to air-source heat pump conversion

- **\$1,000 rebate**
- Pre-approval required. Must submit additional form to PSE and receive pre-approval prior to installation
- Must have an existing electric FAF and upgrade to an AHRI performance certified heat pump with a 8.5 HSPF and 14 SEER or higher
- Cannot have an existing heat pump, including a ductless heat pump, or a gas furnace or gas boiler
- Electric zonal customers are not eligible
- Auxiliary heating sources do not qualify for an additional rebate

### Air-source heat pump

- **Tier 1 - \$200 rebate**
  - 8.5 HSPF or higher
  - 14 SEER or higher
- **Tier 2 - \$350 rebate**
  - 9.0 HSPF or higher
  - 14 SEER or higher
- Heat pump system must be AHRI performance certified
- Customers who do not qualify for the ductless heat pump or electric FAF to heat pump conversion rebates can qualify for this rebate if equipment meets efficiency requirements
- Auxiliary heating sources do not qualify for additional rebates

## Converting to natural gas

When available, PSE recommends using natural gas directly for space and water heating. You may be eligible for conversion rebates. Visit [PSE.com/Rebates](http://PSE.com/Rebates) for more information.

## Natural gas heating systems

### Boiler

- **\$350 rebate**
- Must install ENERGY STAR qualified equipment with a 95 percent Annual Fuel Utilization Efficiency (AFUE) rating or better

### Forced-air furnace

- **\$250 rebate**
- Must install ENERGY STAR qualified equipment with a 90 percent AFUE rating or better
- Cannot have an existing furnace with 90 percent AFUE rating or better

## General qualifications

- Rebate application must be submitted within 90 days of equipment installation
- Qualifying natural gas equipment must be installed in PSE's natural gas service area and qualifying electric equipment must be installed in PSE's electric service area
- Equipment must be installed in 2010
- Applies to existing single-family properties (including manufactured) or individually-metered attached housing with four units or less
- Super Good Cents/ENERGY STAR qualified manufactured homes are not eligible for heat pump rebates
- One rebate per qualifying customer. For air-source heat pump and natural gas boiler and furnace rebates, one rebate per qualifying piece of equipment (not to exceed two)
- Cannot be combined with any other space heating rebate except ducted, air-source heat pump rebates can be combined with PSE's air-source heat pump sizing and lock-out control rebate
- Customers who received an ENERGY STAR natural gas furnace rebate within the last two years do not qualify for any heat pump rebate
- Equipment that is replaced under warranty will not be eligible for a second rebate
- Must install to comply with all federal, state and local code requirements
- PSE may inspect installation for compliance with qualifications
